## **Rebate Terms and Conditions**

### **I. Terms:**

- A. Evaporative Cooler Thermostat (Cooler Thermostat):
  - 1. Cooler Thermostats must be automatic and work only on evaporative coolers (swamp coolers).
  
- B. High-Efficiency Clothes Washer (HE Washer):
  - 1. HE Washers must have an Integrated Water Factor (IWF) of 3.2 or lower based upon the Consortium for Energy Efficiency (CEE).
  
- C. High-Efficiency Toilets (HE Toilets):
  - 1. Tank type or Flushometer (Valve/Bowl combination) type HE Toilets must have an effective flush volume of 1.28 gallons or less as determined by the Environmental Protection Agency (EPA) WaterSense Program or as rated by M.a.P. testing.
  
- D. High Volume Toilet:
  - 1. A high volume toilet is a toilet that has an effective flush volume of more than or equal to 3.0 gallons.
  
- E. Low Flow Toilet:
  - 1. A "low flow toilet" is a toilet that has an effective flush volume of 1.6 gallons.
  
- F. New construction/development for HE Toilets:
  - 1. The home or business must have been built in 1996 or older.
  
- G. Qualifying product list:
  - 1. Cooler Thermostat

  - 3. HE Washer

- H. Rebate Amounts:
  - 1. Evaporative Cooler Thermostat can receive a \$30 credit.
  - 2. HE Toilets can receive a \$100 per toilet.
  - 3. HE Washer can receive a \$100 credit.
  
- I. Receipt:
  - 1. An original or copy of the itemized receipt showing the purchase of the HE Toilet, HE Washer, Cooler Thermostat.

**II. Conditions:**

- A. Rebates only apply to Cooler Thermostats, HE Toilets, and HE Washers.
- B. Applicant, at the time of purchase, must be a water utility service customer of the City of Rio Rancho with an account in their name at the service address where the fixture is installed.
- C. Used or reconditioned Cooler Thermostats, HE Toilets, or HE Washers do not qualify for a rebate.
- D. Rebates do not apply to purchases for new construction and development.
- E. HE Toilets must replace high volume toilets.
- F. Applicant is not eligible for a rebate if he or she has received a Cooler Thermostat, HE Toilet, or HE Washer rebate from the City.
- G. Applicant or Customer is solely responsible for Cooler Thermostat, HE Toilet, or HE Washer installation arrangements and payment.
  - 1. The City does not warrant, endorse, or assume liability for the quality, performance, or safety of any product or services performed by any retail outlet, plumber, contractor, or employees or agents of same, related to a purchase under this program.
- H. Installations may be subject to inspection and verification. Customer agrees to allow the City of Rio Rancho to inspect the fixture at the installation address by appointment with prior notification.
- I. Conversions to Low Flow Toilets do not qualify for a rebate.
- J. All Rebate applications must be accompanied by a receipt.
  - 1. If the receipt is not with the application then the application will be considered incomplete and not processed.
- K. Rebates are issued in the amount of \$30 or \$100 credit to the applicant's water bill account for the installation address.
- L. Rebates are subject to program funding availability.
  - 1. Applications will be processed until funds are depleted.
- M. The City reserves the right, at its sole and absolute discretion and at any time, to change any or all of the Terms and Conditions for the rebate program or to cancel the rebate program without prior notice.
- N. Applicant will be required to repay the rebate if any of these Terms and Conditions are found to have been false or breached.
