## **Outdoor Rebate Terms and Conditions**

### **I. Terms:**

- A. High Efficiency (HE) Rotating Sprinkler Nozzles:
  - 1. HE Rotating Sprinkler Nozzles are compatible with most pop-up sprinkler heads. The rotating streams deliver less water per minute (which will require adjustments to watering times) which helps reduce runoff and erosion. The rotating streams are also more wind resistant which also helps more water to stay in the intended landscaped areas.

- B. Smart Irrigation Controllers:
  - 1. WaterSense labeled irrigation controllers, which act like a thermostat for your sprinkler system, can replace clock-based controllers. WaterSense labeled controllers use local weather and landscape conditions to tailor watering schedules to the actual conditions of the landscape.
  - 2. Smart irrigation controllers must be WaterSense labeled. Use this link to see qualifying product: <https://lookforwatersense.epa.gov/products/>
- C. Rebate Amounts:
  - 1. HE Rotating Sprinklers can receive a credit of \$2 per qualifying sprinkler.
  - 2. WaterSense Smart Controllers can receive a credit of up to \$300 per controller (based on price of smart controller purchased).
- D. Receipt:
  - 1. An original or copy of the itemized receipt showing the purchase of HE Rotating Sprinklers and/or a Smart Controller.

### **II. Conditions:**

- A. These outdoor rebate Terms and Conditions only apply to HE Rotating Sprinkler Nozzles and WaterSense labeled Smart Controllers.
  - 1. The xeriscape rebate program requires pre-approval and uses a different application and has its own Terms and Conditions.
- B. Applicant, at the time of purchase, must be a water utility service customer of the City of Rio Rancho with an account in their name at the service address where the fixture is installed.
- C. Used or reconditioned HE Rotating Sprinklers or Smart Controllers do not qualify for a rebate.
- D. Purchases for new construction and development are eligible for rebates.
- E. Applicant or Customer is solely responsible for HE Rotating Sprinkler Nozzle or Smart Controller installation arrangements and payment.
  - 1. The City does not warrant, endorse, or assume liability for the quality, performance, or safety of any product or services performed by any retail outlet, plumber, contractor, or employees or agents of same, related to a purchase under this program.

- F. Installations may be subject to inspection and verification. Customer agrees to allow the City of Rio Rancho to inspect the fixture at the installation address by appointment with prior notification.
- G. Customers can apply for rebates based on the below timelines:
  - 1. WaterSense Smart Controllers: Once every 5 years
  - 2. HE Rotating Sprinkler Nozzles: Once a year
- H. All rebate applications must be accompanied by a receipt. If no receipt is provided, the application will be considered incomplete and will not be processed.
- I. Rebates are applied as a credit to the applicant's water bill account for the installation address.
- J. Rebates are subject to program funding availability.
  - 1. Applications will be processed until funds are depleted.
- K. The City reserves the right, at its sole and absolute discretion and at any time, to change any or all of the Terms and Conditions for the rebate program or to cancel the rebate program without prior notice.
- L. Applicant will be required to repay the rebate if any of these Terms and Conditions are found to have been false or breached.
