Outdoor Rebate Terms and Conditions

I. Terms:

- A. High Efficiency Sprinkler Rotating Nozzles Multi-Stream (HE Rotating Sprinklers):
 - 1. Rotary Nozzles provide water efficiency and design flexibility. Rotary Nozzles feature rotating stream technology which uniformly delivers water at a low precipitation rate, significantly reducing runoff and erosion.
 - 2. Thick wind-resistant streams ensure efficient performance in adverse real world conditions. Large water droplets cut through the wind so water stays in the target zone without misting or fogging.
- B. Irrigation Controllers (Smart Controllers):
 - 1. WaterSense labeled irrigation controllers, which act like a thermostat for your sprinkler system telling it when to turn on and off, use local weather and landscape conditions to tailor watering schedules to actual conditions on the site instead of irrigating using a controller with a clock and a preset schedule.
 - 2. WaterSense labeled controllers allow watering schedules to better match plants' water needs. With proper installation, programming, and maintenance, homeowners and businesses can use WaterSense labeled controllers instead of standard clock-timer controllers on their existing systems, and no longer worry about wasted water.

- D. Rebate Amounts:
 - 1. HE Rotating Sprinklers can receive a credit of \$2 per sprinkler.
 - 2. Smart Controllers can receive a credit of up to \$300 per controller.
- E. Receipt:
 - 1. An original or copy of the itemized receipt showing the purchase of HE Rotating Sprinklers and or a Smart Controller.

II. Conditions:

- A. Rebates only apply to HE Rotating Sprinklers and Smart Controllers.
- B. Applicant, at the time of purchase, must be a water utility service customer of the City of Rio Rancho with an account in their name at the service address where the fixture is installed.
- C. Used or reconditioned HE Rotating Sprinklers or Smart Controllers do not qualify for a rebate.
- D. Purchases for new construction and development are eligible for rebates.

- E. Applicant or Customer is solely responsible for HE Rotating Sprinkler or Smart Controller installation arrangements and payment.
 - 1. The City does not warrant, endorse, or assume liability for the quality, performance, or safety of any product or services performed by any retail outlet, plumber, contractor, or employees or agents of same, related to a purchase under this program.
- F. Installations may be subject to inspection and verification. Customer agrees to allow the City of Rio Rancho to inspect the fixture at the installation address by appointment with prior notification.
- G. All Rebate applications must be accompanied by a receipt.
 - 1. If the receipt is not with the application then the application will be considered incomplete and not processed.
- H. Rebates are issued in the amount of \$2 per HE Rotating Sprinkler installed and \$300 or actual cost of Smart Controller installed, whichever is less. The rebates are applied to the applicant's water bill account for the installation address.
- I. Rebates are subject to program funding availability.
 - 1. Applications will be processed until funds are depleted.
- J. The City reserves the right, at its sole and absolute discretion and at any time, to change any or all of the Terms and Conditions for the rebate program or to cancel the rebate program without prior notice.
- K. Applicant will be required to repay the rebate if any of these Terms and Conditions are found to have been false or breached.
